A Remarkable Team

What a pair! Diana Sullivan is a volunteer on Wednesdays at the Aphasia Center. She is spirited, effervescent, laughs easily, and had a stroke in 1991. Her husband, Dan, has been her partner for more than 50 years. They seem to be perfectly matched: they grew up within a few streets from one another in Oakland: they went to the same Catholic school and church; they met, fell in love, got married and had three children and five grandchildren. One more thing, they are both the children of immigrants. Dan's parents were from Ireland and Diana's father was from Italy. Even their one big difference has not come between them. Dan didn't have a stroke, but he is a major part of Diana's recovery. There are other differences, too. Dan has a gift of words and a quick Irish wit; Diana has an intense passion for doing the right thing. But they draw strength from their differences and, together, they form a remarkable team.

An example of Diana's desire to do things right came when her mother suffered from Alzheimer's disease. Before Diana's stroke, she took care of her mother for nearly 15 years. While making daily visits to her mother's nursing home, Diana found that the institution had many problems that affected patient care. She became the patients' advocate and, according to Dan, "All the patients in that home would perk up when they saw Diana."

Because of her diligence and support of the elderly, Diana was presented with the Whistle-Blowers

award by Lt. Gov. Leo McCarthy in 1987 for her work. She was also featured in *Parade Magazine* for her courageous work to protect nursing home residents. Diana hadn't realized at the time that many of the women sitting in the hallway at the nursing home had suffered from a stroke. She says, "The women couldn't speak, but their eyes said it all, and they would always smile." Diana remembered those women from the nursing home when she had her stroke.

After Diana's stroke in 1991, she struggled with language skills, especially reading. She would look at a newspaper and just see "black ink" without knowing what the words meant. Dan quips, "She's Italian and she's stubborn. She would sit in front of the TV and listen and watch their lips then emulate them in speaking. And she did it all on her own."

Diana says that it is wonderful to

have Dan who is such a positive, supportive partner to help her go forward. In talking to Diana today, most people wouldn't know that she had survived a stroke. She remembers, in the early days after her stroke, repeating a word or a sentence until she got it. "I knew I was going to have to rewire my brain," she says.

Diana says she still misses the days before her stroke when she could get so much accomplished quickly. Now she works much slower, and instead of doing three things at once, she does one thing. However, she continues to make progress with her aphasia, even 13 years after her stroke, and that is what pushes her to continue her recovery efforts.


Diana met Dr. Roberta Elman and Ellen Bernstein-Ellis more than ten years ago when they were working at the Easter Seals Medical Rehabilitation

Aphasia Awareness Month Resolution

Resolution SCR 83, Perata. California Aphasia Awareness Month.

This measure would declare that the Legislature recognizes June of each year as California Aphasia Awareness Month.

WHEREAS, Aphasia is a communication impairment caused by brain damage, typically resulting from a stroke; and

WHEREAS, While aphasia is most often the result of stroke or brain injury, it can also occur in other neurological disorders, such as in the case of a brain tumor; and

WHEREAS, Many people with aphasia also have weakness or paralysis in their right leg and right arm, usually due to damage to the left hemisphere of the brain, which controls language and movement on the right side of the body; and

WHEREAS, The effects of aphasia may include a loss or reduction in ability to speak, comprehend, read, and write, while intelligence remains intact; and

WHEREAS, Stroke is the third largest cause of death, ranking behind "diseases of the heart" and all forms of cancer; and

WHEREAS, Stroke is a leading cause of serious, long-term disability in the United States; and

WHEREAS, There are about 4.8 million stroke survivors alive today; and

WHEREAS, It is estimated that there are about 700,000 strokes per

year in the United States, with approximately one third of these resulting in aphasia; and

WHEREAS, Aphasia affects at least 1,000,000 people in the United States; and

WHEREAS, More than 200,000 Americans acquire the disorder each year; now, therefore, be it

RESOLVED by the Senate of the State of California, the Assembly thereof concurring, That the Legislature recognizes June of each year as California Aphasia Awareness Month; and be it further

RESOLVED, That the Secretary of the Senate transmit copies of this resolution to the author for appropriate distribution.

Center. After volunteering at Easter Seals for about a year, Diana joined the Aphasia Center of California. In speech therapy, Diana started writing poetry about having a stroke and aphasia. In her first poem, she wrote, "Alone, sadness, confusion! Isolation from my previous life is profound." Diana says that writing poetry is a way for her to express complex ideas and feelings simply.

Diana has been volunteering at the Aphasia Center since 1994. It is inspiring for other stroke participants to see how much Diana has improved. Her husband Dan, who is a volunteer for many Aphasia Center of California projects, agrees. "I'd rather be around the people here at the Center with aphasia than anybody else I can
