# **USA-Japan Aphasia Friendship Day**

On Saturday, June 16, 2007, stroke survivors from Japan cosponsored a program with Aphasia Center of California participants at the North Berkeley Senior Center. More than 35 Japanese stroke survivors and family members traveled to the Bay Area to meet members of the Aphasia Center of California. Both groups gathered together for a fun filled and inspiring day.

Laughter and conversation highlighted the event. The room was filled with 16 tables—each had stroke survivors and family members from Japan, stroke survivors and family members from the Aphasia Center of California, and a Japanese student studying English in San Francisco, who

served as an interpreter. The tables were animated with both conversation and gesture, as Japanese and American stroke survivors found ways around their language barriers in order to communicate with one another. Although the language and culture were different, participants soon found out that the effects of their strokes had been very similar, and they had much in common.

The event began with a getting to know you activity. Participants shook

hands and sang "Good morning To You." Mr. Endo, the speech therapist from Japan, and Dr. Roberta Elman from the Aphasia Center of California, then welcomed everyone to the event.

Japanese stroke survivors and family members then introduced themselves and revealed basic information about their strokes. Stroke survivors and family members from Japan wore beautiful handmade name badges with a large "F" in the middle.



# Education and Training Around the World

Aphasia Center of California's staff members are frequently invited to provide training to speech-language pathologists at home and abroad. In addition, during the last year, we have published two articles in *Topics in Language Disorders*, a peer-reviewed professional journal. Although the Aphasia Center programs may be physically located in California, our philosophy and clinical techniques continue to be shared with speech-language pathologists around the world!

### Book Connection™ Program Expands

The ACC's Book Connection<sup>TM</sup> is an innovative aphasia book club program developed by staff at the ACC. The Book Connection<sup>TM</sup> includes an instruction manual and curriculum materials for more than 18 popular books. These materials are used by speech-language pathologists to offer local book clubs that make popular literature accessible once again to

people living with aphasia. Currently, more than 20 aphasia book clubs have been formed with the ACC's Book Connection<sup>TM</sup>—this includes book clubs in Canada, South Africa, and from sea to shining sea in the USA!

The "F" represented *family*, *friendship*, and *future*. ACC staff then presented aphasia lapel pins to each stroke survivor from Japan as a gesture of welcome. Then it was time for members of the ACC to take the stage and tell about their own strokes. After this introductory activity, both groups realized how much they had in common.

Next a visitor from Japan shared her experiences as the wife of a stroke survivor. Speech-language pathologist, Ellen Bernstein-Ellis then interviewed ACC member, Martha Lynch. Martha spoke about the lessons she had learned from aphasia and shared advice to those living with the results of stroke.

Next lunch was served! Overflowing platters of beautifully prepared Japanese food were set out. Participants enjoyed mouth-watering sushi, sashimi, lobster, shrimp, vegetables and dessert.

Following lunch, Mr. Endo showed color slides of the various activities of his aphasia program in Japan. Mr. Endo described how reading Dr. Elman's book on group treatment, and learning about the Aphasia Center of California, had been the original

inspiration for him to start his program in Japan. It was thrilling to learn that our work at the ACC has made such a significant impact around the world!

Then it was time for some exercise. Enid Meyer, ACC Board member, led the group in Tai Chi exercises to build balance and strength. Her activities were slow and beautiful and had everyone moving. We then joined Liz Lang, ACC student intern, for the song "Head, Shoulders, Knees and Clap." This was quite a challenge as participants had to learn both the English and Japanese versions of the song!

With great feelings of warmth, the event concluded with stroke survivors, their family members, and speech-language pathologists standing in a large circle, holding hands, and singing "Auld Lang Syne."

Meeting stroke survivors from Japan and making new friendships, made this day truly special. Everyone departed US-Japan Aphasia Friendship day feeling happy, inspired, and closely connected to people living with aphasia around the world.
